#### **PUBLIC COMMENT**

Fran Kenny of 225 N. 36<sup>th</sup> Avenue – requested that a No Idling sign be placed and enforced near Lamberti's restaurant . She noted that on several occasions there have been very large trucks idling there and that the fumes have caused her to close her windows. There was additional discussion on the idling issue and it was suggested that Ms. Kenny contact the police department right away.

Doug Farrell of 16 S.  $32^{nd}$  Avenue – noted that he was in favor of the dune project in Longport. He had concerns regarding existing dunes and that if they were destroyed it would have negative impacts upon the existing wildlife. There was continued discussion on the dune project.

Sabrina Blankenship of 1204 Atlantic Avenue noted that the website and calendar are outdated. She recommended hiring an IT expert for repairs and Internet.
