#### **Preface**

The purpose of this Ordinance is to correct, add, and delete certain designated handicapped parking spaces for improved disabled person access at various locations within the Borough.

#### BE IT ORDAINED BY THE COMMISSIONERS OF THE BOROUGH OF LONGPORT that:

SECTION 14.1: Schedule 2A: Handicapped Parking is being deleted and replaced with the following Chapter 161-14.1 Schedule 2A Handicapped Parking:

#### **SECTION II:**

All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgement shall not affect, impair, or invalidate the remainder of this Ordinance.

IC.

No truck or other vehicle making deliveries in the Borough, including but not limited to, vehicles making deliveries of articles to be transferred onto any other vehicle; may not drop or transfer freight or other items on any public right of way. The Police Chief upon request may, in his sole discretion, provide an exemption to this provision if warranted.]

#### **SECTION 2:** Longport Code Chapter § 161-10 shall be amended as follows:

In addition to any other penalties herein provided, any person violating any of the provisions of this chapter shall, upon the conviction thereof by the municipal court, be punishable by a penalty of \$100 [\$500] for a first offense; subsequent offenses to be \$100 [\$500.00] minimum and/or up to 90 days' community service.
