**NOTICE** is hereby given that the Borough of Longport Board of Commissioners will hold a SPECIAL Meeting of Thursday, April 29, 2021 at 4 pm. The purpose of this meeting is to designate bank signatories regarding the Share Municipal Court Service between the Borough of Longport and the City of Margate City, to retain a hearing officer for a personnel matter and to award the Longport Fire Boat Dock Construction to Trident Marine Construction. The meeting will be held In-Person AND via Teleconference due to meeting room capacity restrictions as a result of the COVID-19 Pandemic. The meeting begins at 4 pm. The in-person meeting room capacity is 30 persons. Those attending in person must wear a face covering and practice social distancing. Longport Borough Hall is located at 2305 Atlantic Avenue, Longport, New Jersey.

Those participating who exceed the limit or are found to be disruptive of meeting proceedings will have their microphone muted. Members of the public that are attending remotely that wish to submit public comments and/or questions in advance of the meeting must provide that information by 12 noon the day preceding the Board of Commissioners Meeting.
