**ESTABLISHMENT OF AN EMERGENCY 'NO PARKING' AREA, CLOSURE,
AND DETOURING ON VARIOUS STREETS DURING SJG CONSTRUCTION**

WHEREAS, The Contractor for the South Jersey Gas Company, **Lantier Construction**, will be performing high pressure gas main installation on various streets throughout the Borough; and

WHEREAS, due to this construction a temporary condition exists necessitating special traffic regulations on the Various Streets as listed below; and

WHEREAS, in accordance with N.J.S.A. 39:197.3, a Municipality has the right to permit special traffic regulations when circumstances of this type dictate its necessity.

NOW THEREFORE BE IT RESOLVED by the Commissioners of the Borough of Longport that it hereinafter authorizes the following temporary special traffic regulations, including but not limited to the closing and detouring of traffic during actual construction activities, to be implemented by the Longport Police Department in the Borough of Longport, Atlantic County, New Jersey:
