**AUTHORIZING A NON FAIR AND OPEN PROFESSIONAL SERVICES CONTRACT
WITH GENE ROSSI (SYSTEMS FOR YOU) AS IT CONSULTANT IN THE
ESTABLISHMENT OF A LIBRARY FACILITY
IN MUNICIPAL HALL
2305 Atlantic Avenue**

WHEREAS, the Borough of Longport is in need of the creation of a Library Facility within the former Library space in Municipal Hall; and

WHEREAS, **Gene Rossi (Systems for You)** is experienced in the operation of a computers and is the computer repair/consultant for the Borough of Longport; and

WHEREAS, the Borough desires to enter into a Services Contract with **Gene Rossi** pursuant to the provisions of NJSA 19:44A-20.5; and

WHEREAS, such services with be invoiced at the rate of \$90.00 per hour as outlined in the Proposal attached to this Resolution and shall not to exceed **\$8,000.00**; and

WHEREAS, the anticipated term of said Services is not for more than one year; and

WHEREAS, **Gene Rossi** has completed and submitted a Business Entity Disclosure Certification which certifies that **Gene Rossi** has not made any reportable contributions to a political or candidate committee in the Borough of Longport within the previous one year and, further, that this Contract will prohibit **Gene Rossi** from making any reportable contributions through the term of this Contract; and

WHEREAS, a Certificate of Availability of Funds has been issued by the Municipal Chief Financial Officer and is attached to this Resolution.

NOW, THEREFORE BE IT RESOLVED by the Governing Body of the Borough of Longport that it hereby accepts the conditions as as outlined in the attached Proposal from **Gene Rossi** and hereby directs the Chief Financial Officer to authorize **Gene Rossi** to proceed with the work as outlined in said Proposal; and

BE IT FURTHER RESOLVED that a Notice of this Contract Award shall be published at least once in the Atlantic City Press pursuant to the requirements of Chapter 198 of the New Jersey Laws of 1971.
