**AUTHORIZING THE EXECUTION OF A DEED OF DEDICATION AND
PERPETUAL SHORE PROTECTION EASEMENT TO THE
N.J. DEPARTMENT OF ENVIRONMENTAL PROTECTION
FOR BLOCK 1 LOT 13 FOR THE CONSTRUCTION OF
THE LONGPORT POINT REVETMENT PROJECT
STATE AID PROJECT 4270-15**

WHEREAS, Superstorm Sandy caused extensive damage to life and property in the Municipalities along the Atlantic Coast of New Jersey, including flooding and erosion along portions of the Borough of Longport; and

WHEREAS, Superstorm Sandy revealed that improved and enhanced flood hazard risk reduction and shorefront protection measures are necessary along the coastlines of New Jersey for the protection of the Public Health, Safety, and Welfare; and

WHEREAS, in response to the devastation from Superstorm Sandy, the New Jersey Department of Environmental Protection has appropriated State Aid Funding for the creation, improvement, and reconstruction of the Longport Point Revetment (Project); and

WHEREAS, the Governing Body of the Borough of Longport agrees that the construction of this Project in concert with the N.J. Department of Environmental Protection is in the best interests of the Municipality and the Property Owners and Citizens therein; and

WHEREAS, the N.J. Department of Environmental Protection, as a condition of finding and commencing construction of the Project, requires that the Municipality execute a Deed of Dedication and Perpetual Shore Protection Easement for the land designated on the Municipal Taxing Map as Block 1 Lot 13; and

WHEREAS, the passage of this Resolution will authorize the Mayor to execute the Deed of Dedication and Perpetual Shore Protection Easement in order for the Project to proceed without further delay.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Longport, County of Atlantic that the Mayor be and is hereby authorized to execute and Deed of Dedication and Perpetual Shore Protection Easement for Block 1, Lot 13 between the Borough of Longport and the N.J. Department of Environmental Protection as indicated on the attached documents.
