**AUTHORIZING THE BOROUGH'S PARTICIPATION IN THE SOURCEWELL CO-OP FOR
CONTRACT # 062117-DAC, GROUNDS MAINTENANCE
EQUIPMENT/ATTACHMENTS/ACCESSORIES, WITH DEERE & COMPANY.**

WHEREAS, the Borough of Longport is allowed to participate in national purchasing cooperative per N.J.S.A. 52:34-6.2 (b) P.L. 2011, c.139 which was enacted into law permitting agencies to utilize national purchasing cooperatives; and

WHEREAS, Sourcewell acts as the lead agency and awarded Contract # 062117-DAC, to purchase Grounds Maintenance Equipment/Attachments/Accessories; and

WHEREAS, the Department of Public Works, Police Department, Fire Department and Beach Patrol are in need of a three Gators Vehicles for beach and dune maintenance, beach patrolling, and patron assistance/medical responses respectively; and

WHEREAS, the heads of the four departments and Jenna Kelly, CFMO/QPA, Chief Financial Officer have researched the available Gators and determined that the John Deere XUV825M S4 (MY 18) and John Deere XUV835M HVAC (MY 18) units are functional economic vehicles for the Borough of Longport; and

WHEREAS, the four department heads and Jenna Kelly, CFMO/QPA, Chief Financial Officer have reviewed the contract from Sourcewell Contract #062117-DAC, Grounds Maintenance Equipment/Attachments/Accessories with the award to vendor Deere & Company (delivering dealer: Central Jersey Equipment LLC); and

WHEREAS, it is recommended that the Borough Commission approve the purchase of two (2) model year 2018 or newer John Deere XUV825M S4 (MY18) Gators for use by the Police Department, Fire Department and Beach Patrol and one (1) John Deere XUV835M HVAC (MY18) Gator for use by the Public Works Department for daily work operations throughout the Borough from Deere & Company;

WHEREAS, The Borough of Longport previously passed Resolution 2018-74, approving this purchase; however, the price increased due to varying factors including the timeframe for delivery.

NOW THEREFORE, BE IT RESOLVED by the Borough Commissioners of the Borough of Longport that Resolution 2018-74 is hereby repealed and amended as distinguished herein; and,

NOW THEREFORE, BE IT FURTHER RESOLVED by the Borough Commissioners of the Borough of Longport, New Jersey, that two (2) model year 2018 or newer John Deere XUV825M S4 (MY 18) Gators and one (1) John Deere XUV835M HVAC (MY18) for use by the Department of Public Work, Police Department, and Fire/Beach Patrol be purchased from Deere & Company., Sourcewell Contract #062217-DAC as follows:

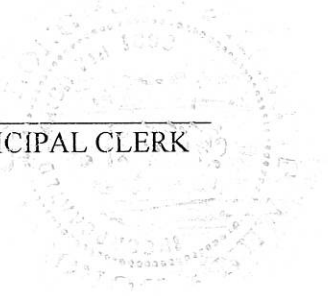
