AN ORDINANCE AMENDING CHAPTER 161 - VEHICLES AND TRAFFIC  
OF THE CODE OF THE BOROUGH OF LONGPORT  
ATLANTIC COUNTY NEW JERSEY  
AS IT PERTAINS TO HANDICAPPED PARKING**

**Preface**

The purpose of this Ordinance is to add designated handicapped parking spaces for improved disabled person access at various locations within the Borough.

**BE IT ORDAINED BY THE COMMISSIONERS OF THE BOROUGH OF LONGPORT that:**

**SECTION 1:** The following locations are added to Paragraph A. in **Chapter 161-14.1 Schedule 2A Handicapped Parking:**

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
18 <sup>th</sup> Avenue	West	From a point 15 feet North of the Northerly curbline of Beach Terrace and extending to a point 40 northerly therefrom
20 <sup>th</sup> Avenue	West	From a point 35 feet South of the Southerly curbline of Atlantic Avenue and extending to a point 40 feet southerly therefrom
28 <sup>th</sup> Avenue	East	From a point 70 feet North of the Northerly curbline of Ventnor Avenue and extending to a point 40 feet northerly therefrom

**SECTION II:** All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgement shall not affect, impair, or invalidate the remainder of this Ordinance.

**SECTION III:** This Ordinance shall take effect immediately upon passage and publication as required by Law.
