AN ORDINANCE AMENDING CHAPTER 161 - VEHICLES AND TRAFFIC OF THE CODE OF THE BOROUGH OF LONGPORT ATLANTIC COUNTY NEW JERSEY AS IT PERTAINS TO NO PARKING ON ATLANTIC AVENUE

Preface

The purpose of this Ordinance is to remove the Seasonal Restriction of No Parking on the South Side of Atlantic Avenue between May 15 and September 15 and permit parking on the South Side at all times.

BE IT ORDAINED BY THE COMMISSIONERS OF THE BOROUGH OF LONGPORT that:

SECTION 1: The following Street is deleted from Chapter 161-13.1 Schedule 1A Seasonal No Parking:

Name of Street Side Location

Atlantic Avenue South 11th Avenue to 15th Avenue

SECTION II: All other Ordinances or parts of Ordinances which are inconsistent with the provisions of

this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgment shall not affect, impair, or invalidate the

remainder of this Ordinance.

SECTION III: This Ordinance shall take effect immediately upon passage and publication as required by

Law.

SECTION IV: The Certification from the Municipal Engineer is attached hereto.
