

BOROUGH OF LONGPORT  
ORDINANCE 2017-08  
**AN ORDINANCE AMENDING CHAPTER 57 OF THE CODE OF THE BOROUGH OF LONGPORT  
ALCOHOLIC BEVERAGES**

**PREAMBLE:** The Borough of Longport conducts a Farmer’s Market on weekends during the summer months. Alcohol vendors have expressed a desire to sell their beverages at the Farmer’s Market. Therefore, the Governing Body of the Borough of Longport does hereby **ORDAIN**, that in accordance with law and under the authority of New Jersey Statute 33:1-1 et seq. Chapter 57 of the Revised General Ordinances of the Borough of Longport be amended to allow for alcoholic beverages to be sampled and sold at the Longport Farmer’s Market.

**SECTION 1** The following paragraph is added to **Subsection 57-10** of the Code of the Borough of Longport; as follows:

- A. The hours of sale limitation set forth in paragraph 57-10 are not applicable to sales and sampling of alcoholic beverages sold at the Longport Farmers Market provided all necessary State and local approvals are obtained.

**SECTION 2** The following paragraph will be amended to Subsection 57-18 of the Code of the Borough of Longport; as follows:

No person shall, on any public or quasi-public property, in or not in a private conveyance, within the Borough of Longport;

- A. Consume any alcoholic beverage
- B. Be in possession of an opened or unsealed container of any alcoholic beverage.
- C. The foregoing restrictions shall not apply to alcoholic beverages sold or sampled at the Longport Farmer’s Market provided all applicable permits and authorizations have been obtained.

**SECTION 3.** This ordinance shall take effect immediately upon final passage and publication in accordance with law.

**SECTION 4.** The provisions of this ordinance shall be severable. In the event that any portion of this ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgment shall be limited in its effect only to the operation of any other portion thereof, which shall remain in full force and effect.

**SECTION 5.** All other ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

**BE IT SO ORDAINED.**
