AN ORDINANCE AMENDING CHAPTER 161 - VEHICLES AND TRAFFIC OF THE CODE OF THE BOROUGH OF LONGPORT ATLANTIC COUNTY NEW JERSEY AS IT PERTAINS TO NO PARKING ON ATLANTIC AVENUE BETWEEN 11TH AVENUE AND 15TH AVENUE

The purpose of this Ordinance is to reinstate the Seasonal Restriction of No Parking on the South Side of Atlantic Avenue between May 15 and September 15 and permit parking only between September 15 and May 15.

BE IT ORDAINED BY THE COMMISSIONERS OF THE BOROUGH OF LONGPORT that:

The following Street is added to Chapter 161-13.1 Schedule 1A Seasonal No Parking: SECTION 1:

SECTION II:

All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

Law.
