BOROUGH OF LONGPORT ORDINANCE NO. 2019-03

AN ORDINANCE AMENDING ARTICLE VI – STREET CONSTRUCTION CURBLINE TO PROPERTY LINE AS IT PERTAINS TO CONSTRUCTION ALONG 22ND AVENUE AND PART OF ATLANTIC AVENUE IN CHAPTER 147-STREETS AND SIDEWALKS OF THE CODE OF THE BOROUGH OF LONGPORT ATLANTIC COUNTY NEW JERSEY

Purpose: The purpose of this Ordinance is to coordinate construction within the sidewalk with the requirements as stated in Chapter 167-39 C. The additional purpose of this Ordinance is to require the installation of specific sidewalk brick within what is referred to as the 'Governor's Strip' for only the properties fronting on 22nd Avenue with the intent to maintain an historical appearance in the Block. The brick within the 'Governor's Strip' will also apply to the corner properties at Atlantic and 22nd Avenue permitting the sidewalk brick to be constructed along the corner lot frontage with Atlantic Avenue.

SECTION I: The following paragraph is added to Chapter 147-21. Governor's Strip:

(6) The sidewalk apron area (Governor's Strip) along both sides of 22nd Avenue and for the portion of Atlantic Avenue fronted by the corner lots of 22nd Avenue and Atlantic Avenue shall have the existing yellow sidewalk brick reset for the entire width of the lot with the exception of the driveway access and any concrete access pan constructed in accordance with Paragraph (1) above. The yellow sidewalk brick shall be reset in a three (3) inch mortar base with tight joints and at a cross slope to match that of the sidewalk assuring positive drainage to the top of the curb and into the street gutter. The longest dimension of the brick shall be constructed perpendicular to the concrete curbing.

SECTION II: All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

SECTION III: This Ordinance shall take effect immediately upon passage and publication as required by Law.
