BOROUGH OF LONGPORT ORDINANCE NO. 2019-10

AN ORDINANCE AUTHORIZING SIGNAGE AT STREETENDS FOR PUBLIC ACCESS TO TIDAL WATERS IN THE BOROUGH OF LONGPORT ATLANTIC COUNTY, NEW JERSEY

Purpose: The purpose of this Ordinance is notify the public of access points to tidal waters at street ends and to periodically review the signs for adequateness.

Whereas, the Borough of Longport ("Borough") encourages the maintenance of public access points to tidal waters; and

Whereas, the Borough has developed, in conjunction with the New Jersey Department of Environmental Protection, a Municipal Public Access Plan which requires, as does applicable law, signage advising the public of the areas available for public access.

Now Therefore:

- 1. The Borough shall develop and maintain signage at each street end public access point to tidal waters appropriate to alert the public of such access points.
- 2. The Director of Public Safety shall each year review such signage and confirm the adequateness of such signage.

All other Ordinances or parts of Ordinances which are inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies, are hereby repealed. Should any section, subsection, clause, or portion of this Ordinance be adjudged by a Court of competent jurisdiction as invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

This Ordinance shall take effect immediately upon passage and publication as required by Law.
